RE: August 2010 Drug Test Statistics (Adult Arrestees)

Drug testing of adult arrestees for August 2010 revealed a 1% decrease in the overall positive test rate (down from 35% to 34%) from July 2010. Cocaine and PCP positives revealed a 1% decrease respectively from July 2010. Opiate positives revealed a 1% increase from July 2010.

The breakdown of August 2010 test results is as follows:
